From the West via Route 17

Take Route 17 East to Exit 130A (Bear Mountain) to Route 6 East/Long Mountain Parkway. Follow Route 6 East to the Queensboro Traffic Circle. From the circle make the third right onto the Palisades Interstate Parkway (PIP) North to the end (past Exit 19). From the Bear Mountain Traffic Circle, follow signs to 9W south. Follow signs to the parking lots.

From the NYS Thruway

Take NYS Thruway I-87 to Exit 16. Pass through tollbooth. Take the first exit on right and then turn left at light. Turn left at the fourth set of traffic lights onto Route 6 (Long Mountain Parkway) East and follow signs to Bear Mountain Bridge. At the Queensboro Traffic Circle make the third right onto the Palisades Interstate Parkway (PIP) North to the end (past Exit 19). From the Bear Mountain Traffic Circle, follow signs to 9W south. Follow signs to the parking lots.

From Westchester

Take NYS Thruway I-87 to Route 287 West. Go over the Tappan Zee Bridge. Take Exit 13N onto the Palisades Interstate Parkway (PIP) heading North. Take the PIP to the end (past Exit 19). From the Bear Mountain Traffic Circle, follow signs to 9W south. Follow signs to the parking lots.
